Hauptseminar Vergleichende Politikwissenschaft: The Rise (and Fall) of New Parties and the Stability of Party Systems

Course description:

Although party systems in advanced democracies are generally rather stable, new parties emerge from time to time with some of them being able to survive more than a few years. However, the number of new parties varies considerably between countries and over time. When do new parties emerge? What makes them survive? The seminar gives an overview of concepts and findings in this research field, combining quantitative approaches with case studies on specific parties, party families, and countries.

As the seminar's overarching goal is to enable participants to write their own research papers on individual cases based on a broad set of explanatory factors introduced and discussed in class, regular attendance is of utmost importance for the quality of term papers.

Participants are expected to hand in a two pages outline of their planned term papers either on 12 June or on 19 June. I will give feedback in my office hour on 16 June and 23 June respectively.

- attend sessions regularly
- actively contribute to class discussions
- complete assigned readings according to schedule
- give a presentation in the seminar (for all participants)
- write a term paper of about 15 pages in length (individual research papers, team research papers with individual contributions of about 8 pages), handed in on 15 September 2015 (late assignments will be penalized, unless prior arrangements are made!).

Since nearly all reading assignments are in English, this will be the general classroom language as well. Participants therefore must know enough English to be able to participate actively. Perfection is not required – you just need to understand and make yourself understood.
